Title page	<ul style="list-style-type: none"> <li><input type="checkbox"/> Category of paper, article title, full names of authors, affiliations are provided.</li> <li><input type="checkbox"/> Short running title is less than 50 characters.</li> <li><input type="checkbox"/> The name, e-mail address, mailing address (affiliation, region, country, zipcode), telephone and fax number of the corresponding author are provided.</li> <li><input type="checkbox"/> References are written in square brackets.</li> </ul>
Cover Letter	<ul style="list-style-type: none"> <li><input type="checkbox"/> The name, address, telephone, fax number, e-mail address of the corresponding author are included.</li> <li><input type="checkbox"/> A potential conflict of interest is disclosed.</li> </ul>
Abstracts and Key Words	<ul style="list-style-type: none"> <li><input type="checkbox"/> The abstracts are less than 300 words with headings Objectives, Methods, Results, Conclusion. For case reports, abstracts are unstructured.</li> <li><input type="checkbox"/> Key Words up to 6 are included using the medical subject headings (MeSH) list of Index Medicus in alphabetical order.</li> </ul>
Text	<ul style="list-style-type: none"> <li><input type="checkbox"/> Each section is consecutively numbered (Introduction, Materials and methods, Results, Discussion, Conclusion) (1. 1.1 1.1.1)</li> <li><input type="checkbox"/> In acknowledgment, the declaration of any source of financial support is provided.</li> </ul>
Reference	<ul style="list-style-type: none"> <li><input type="checkbox"/> References are numbered consecutively in the order they appear in the text and are listed.</li> <li><input type="checkbox"/> References are completed with the full title of the article, the last names and initials of all authors up to 6. If there are 7 or more authors, they are followed by "et al."</li> </ul>
Table	<ul style="list-style-type: none"> <li><input type="checkbox"/> Abbreviations for journal titles conform to those used in MEDLINE.</li> <li><input type="checkbox"/> Tables are numbered in the order they appear in the text.</li> <li><input type="checkbox"/> Each table with the table heading (no longer than 10 to 15 words) is typed double-spaced on a separate sheet. If the same table continues on a second sheet, the title is followed by "cont".</li> <li><input type="checkbox"/> Only horizontal lines are used.</li> </ul>
Figure	<ul style="list-style-type: none"> <li><input type="checkbox"/> Photomicrographs include the type of specimen, original magnification, and stain.</li> <li><input type="checkbox"/> Figures (line drawings or photographs) are in high-resolution EPS or TIFF format (or in high-resolution JPEG format) with a minimum of 500 dpi.</li> <li><input type="checkbox"/> Figures and tables are named according to the figure number and format.</li> <li><input type="checkbox"/> Multiple figures under one figure number are marked on the photographs using capital alphabet letters at the lower right corner.</li> </ul>
